This review was conducted in light of the conceptual framework stated below.




Fig 1: Conceptual Framework

Politicization of the religion was believed to lay a foundation for their expansion. Most of the religious wars are merciless for the human life. Al-Qaeda Violent Youth Movement is one of the religious wars that have been sparked in Europe. It served as an embodiment of radical ultra-leftism. Its objectives are the same as those of the ultra-left in the past, including US imperialism and signs of globalization (Marc Sageman, 2004) [5]. This group also had a transversal agenda that included an abrupt turn toward suicidal violence (the random killing by a student of schoolmates and teachers in his school, before shooting himself or being shot). The individuals in this group believed that terrorism was heroic (Marty, 1960) [4].

As stated in (Nakashima, 2008) [3], Islamo-nationalist radicalism was another challenge for the world in the past few decades. In most of the countries with the majority of Islamic population, this kind of ideology was largely run by the activists and jihadists for the interest of power. Countries like Afghanistan, Turkmenistan, Syria, Libya, Yemen, Turk, Somalia (Al-Shabab), Bangladesh (Rohingya), India, Nigeria (Boko Haram) and so on are experiencing such a bitter life even now days. Belgium and Netherlands were also victimized with the religio-political ideology that distorted their balance of power among the political representatives from different religious background including Catholicism

and the like. A lifelong fight between Israel and Palestine also was the agenda of religious expansion to the territory from both sides.

## **Ethnic Movements That Led to Human Deaths**

This days, Ethnic diversity is prevalent to varied degrees and forms on all continents. The majority of African nations adopted higher levels of diversity than others (McCandless. E and Karbo. T (ed), 2011) [6]. The ethnicization of state institutions and ethnic clientelism, in which various tribes compete to appoint their own representatives t important political and economic positions, are the fundamental causes of the persistence, escalation, and intensity of ethnic tension and violation throughout Africa. The absence of effective political and administrative structures that take in to account ethnic differences and interests is the other primary cause of ethnic conflicts on the continent. Such conflicts are often not fueled by ethnicity, but rather by political leaders trying to gain power, money and resources (Tronvoll K. (2003) [9].

Over the last four years, the Great Lakes region of Africa has seen hundreds of thousands of fatalities. The majority of them were defenseless civilians who had been sacrificed by armies or militias or who had been wiped out by disease or starvation while evading danger. These atrocities can be linked to fierce power struggles carried out by leaders' conflicts that involved the ethno-politization of fear and violence. The conflicts have been based in part on theoretical underpinnings and historical mental maps (Musoni, P. 2004)<sup>[7]</sup>.

Even in a multi-cultural and ethnic country Ethiopia, ethnic clashes and conflicts are a recent and unforgettable history in human species. Political interests among different ethnic groups like Oromo, Amhara, Sidama, Tigre, Somali, Afar and other ethnic groups not mentioned here aggravated intergovernmental war between the civilians (Asnake, 2002) [1]. A civil war held between Tigre force and Ethiopian government that has been disabled nearly last week was a major tangible example to talk about the causes of ethnic conflict in and across the globe. In this genocidal conflict, thousands were died and millions were fought until the agreement made between few leading bodies.

The table above shows that out of the 30 genocidal events across the globe, Christian civilization accounts the highest death records (33 million) in the highest frequency of genocide (14/30). whereas the death toll in the Primal-Indigenous category was the lowest in the genocide category with 1,500 deaths) as stated in Body Count, (2009).




Fig 2: Number of death tolls estimated from global ethnic conflict by Salehyan et.al 2012
